General Terms and Conditions Applicable

The Namibia Statistics Agency may amend or supplement the General Terms and Conditions mentioned hereunder to suit its procurement requirements.]

1. Employer

The NSA invites the bidders to submit Quotations for the purpose of entering into a contract with the successful bidder.

2. Service Provider

The bidder having submitted the lowest price and whose offer is substantially responsive to the requirements specified shall be selected for award and referred to as the Service Provider.

3. Rights of Public Entity

The NSA shall have the rights to

- (a) ask for clarifications at time of evaluating quotations and
- (b) reject all quotations.

NSA not be bound to accept the lowest or any quotation.

4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- (a) have a valid company Registration Certificate;
- (b) have an original valid good Standing Tax Certificate;
- (c) have an original valid good Standing Social Security Certificate;
- (d) have a valid certified copy of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998;
- (e) have a certificate indicating SME Status (for Bids reserved for SMEs);
- (f) Submit signed Bid-securing Declaration.
- (g) An undertaking on the part of the Bidder that the salaries and wages payable to its personnel in respect of this proposal are compliant to the relevant laws, Remuneration Order, and Award, where applicable and that it will abide to sub-clause 4.6 of the General conditions of Contract if it is awarded the contract or part thereof; and;

5. Bid Securing Declaration

Bidders are required to subscribe to a Bid Securing Declaration for this procurement process. The bidder shall furnish as part of its quotation, a Bid Securing Declaration as per the format contained in Schedule 1 of this document.

6. Prices

Prices shall be quoted in Namibian dollars. Prices quoted shall be firm and fixed during the validity period of quotation and for execution of the contract.

7. The Contract

The letter of Acceptance/Purchaser Order Form as the case may be together with this Quotation form shall constitute the contract between the NSA and the Service Provider

8. Purchase Order

- A service provider to whom a purchase order is issued must confirm the purchase order within **three (3) days** of receipt of the purchase order and;
- (a) May not change or alter the terms of the purchase order; and
 - (b) must undertake to deliver the services on or before the date set in the purchase order for delivery of the services.
 - (c) the purchase order shall be valid for **30 days** only and will be canceled thereafter.

9. General Conditions of Contract

The general terms and conditions shall be as per the General Conditions of Contract (Services) Ref. No.- **W/RFQ/NSA-1/2024** posted on the website of the Policy Unit and on the *Namibia Statistic Agency* website.

10. Warranty

The service provider warrants that the services provided shall conform to the standards, and specifications as defined by the Purchaser in its Invitation for Quotation subject to any alternative proposal made by the service provider in its response to the Purchaser's Invitation for Quotation.

11. Payment

The Employer undertakes to effect payment within **30 days** after completion of the services to the satisfaction of the Client subject to the Service Provider making good all defects and submitting all required documents to initiate payment. Final payment shall be adjusted to reflect any noncompliance in the execution of the contract.

12. Project Manager
